Expect the event to conclude between 7:30 PM and 7:45 PM.

No one who is under the influence of alcohol or drugs will be allowed to participate in the Victim Impact Panel.
There will be security on site and breathalyzers may be administered if there is suspicion of alcohol/drug use.
No one under the age of 16 is allowed to enter.
